Overview

Powering all Corvus Integration identity solutions is the **Raven™** identity management application. Raven provides full-function enrollment, matching, and verification capabilities through an intuitive, user-friendly interface supporting all of the most common biometric modalities. Raven supports capture of biometric data and collection of biographical information from multiple sources, stores data in a local database, and exports biometric records for use with external systems via standard EFTS/EBTS and XML data formats.

Raven™ supports collection of face, fingerprint, iris, voice, signature, and palm and biometric matching (1:n) and verification (1:1) for face, fingerprint, and iris. In addition, Raven supports ICAO document (passport and visa) review/verification by reading MRZ, face image, and any associated smart chip data.

- Accepts captured and imported images
- Interfaces with the Corvus Transmission Manager to seamlessly transfer records to a backend server/AFIS/ABIS for verification, identification, and enrollment
- Easily configurable user interface data fields
